## Holland, et. al. vs. Securitas Security Services, USA, Inc.

- 1. On February 18, 2011, Plaintiffs Michael J. Holland, David Richardson and Geraldine Evans ("the Holland Plaintiffs"), filed a Motion for Class Certification ("Motion").
- On June 10, 2011, Defendant Securitas Security Services USA, Inc. ("Defendant"), filed its Opposition to Plaintiffs' Motion for Class Certification ("Opposition").
- After the Holland Plaintiffs received Defendant's Opposition, Defendant produced additional documents which the Holland Plaintiffs assert are relevant to and support class certification.
- 4. At the further status conference on December 6, 2011, the Court ordered that the original Motion and Opposition be withdrawn so that the Holland Plaintiffs can file a new Motion, which incorporates both the previously submitted evidence and evidence that was obtained after the original papers were filed.

#### **STIPULATION**

## Holland, et. al. vs. Securitas Security Services, USA, Inc.

The Holland Plaintiffs and Defendant, through their respective attorneys of record, stipulate that the hearing date for the Holland Plaintiffs' Motion and the corresponding briefing schedule shall be as follows:

- The Holland Plaintiffs shall file and serve their Motion for Class Certification on February 15, 2012.
- Defendant shall file and serve its Opposition to the Holland Plaintiffs' Motion for Class Certification on March 29, 2012.
- The Holland Plaintiffs shall file their Reply to Defendant's Opposition to Holland Plaintiffs' Motion for Class Certification by April 27, 2012
- 4. The hearing on the Holland Plaintiffs' Motion for Class Certification shall take

place on May 22, 2012, at 10:00 a.m., in Department 308.

If the Court is unavailable for hearing on May 22, 2012, the Parties are agreeable to have the hearing on the Holland Motion for Class Certification continued to a date thereafter. The parties also agree that they may, either jointly or individually, seek a further continuance of the above schedule if the California Supreme Court does not issue its decision in Brinker Restaurant Corp. et al. v. Superior Court of San Diego (S166350) by early February, 2012, as currently scheduled, as the parties believe that the decision in that case may impact the analysis of the Holland Motion.

## Walter Linares, et. al. vs. Securitas Security Services, USA, Inc.

- On June 14, 2011, Plaintiffs Walter Linares, Charles Dunaway and Sandra Blacksher ("the Linares Plaintiffs"), filed a Motion for Class Certification ("Motion").
- On October 31, 2011, Defendant Securitas Security Services USA, Inc.
  ("Defendant"), filed its Opposition to Plaintiffs' Motion for Class Certification
  ("Opposition"), pursuant to stipulated order granting Defendant additional time to
  engage in discovery and file the Opposition.
- On December 7, 2011, counsel for Defendant, counsel for the Holland Plaintiffs, and counsel for the Linares Plaintiffs had a conference call and conferred at length on further scheduling.
- Defendant's Opposition includes approximately 85 declarations of putative class members and a lengthy report by Defendant's expert. The Linares Plaintiffs have determined that they need additional discovery for their Reply to the Opposition, including:
  - a. The deposition of Defendant's expert.
  - b. Depositions of approximately 20 of the putative class members whose
